The attached bulletin is being given to you to make you aware of a sex offender that is going to be living in the Town of Addison. Please read the bulletin and if after reading it you have any additional questions or concerns about this sex offender I encourage you to contact one of the individuals listed at the bottom of the bulletin. The reason for this bulletin and letter is not to increase fear in the community, but rather the Sheriff's Office is committed to keeping the citizens of Washington County informed about potential risks in their community.

The Sheriff's Office and agents from the Department of Corrections will make regular unscheduled visits to this sex offender's residence to ensure he is complying with his release requirements. Besides this sex offender there are other registered sex offenders which reside in your community and every other community in Washington County. The Sheriff's Office makes it our practice to also make routine unscheduled visits of those sex offenders to ensure they are complying with their registration requirements. We encourage citizens to stay informed and aware of all known sex offenders living in their community. The Sheriff's Office encourages you to go the Sex Offender Registry Website listed below and inform yourself and family about other sex offenders living in your community.

The Sheriff's Office believes making yourself and family aware of known sex offenders in the community is only the first step in keeping your family safe. Whereas the sex offender in this bulletin has an extensive set of rules to follow and will be closely monitored and tracked, it is also important to educate your family about the potential of sex offenders who are living in the community, but have not been apprehended by law enforcement. Conversations with your children about having contact with strangers, knowing who they are associating with and making sure they report when they believe someone is doing something inappropriate are equally important for your family's safety.

We know the release of sex offenders into the community is uncomfortable, but we hope releasing this information keeps you better informed and serves as a way to speak with your family about other risks in your community. If you have any questions, concerns or would like to speak with someone more about sex offenders and safety in your community please contact the Sheriff's Office.

## Community Notification

July 1, 2012

The Washington County Sheriff's Office is releasing the following information pursuant to WI Statute 301.46(2m) which authorizes law enforcement agencies to inform the public of a sex offender's release when, in the discretion of the agency, the release of information will enhance public safety, awareness and protection. The individual who appears on this notification has been convicted of a sex offense. Further, his criminal history places him in a classification level which reflects the potential to re-offend.

Kelly R. Woodall 43, has been released from prison and is currently residing in the Washington County Jail. Woodall has been searching for a residence throughout Washington County and has located a residence at 505 Main St, Allenton in the Township of Addison, which he will begin residing at on 7/6/2012. Woodall was convicted of Unlawful Sexual Intercourse with a Minor in California in 1987, 4<sup>th</sup> Degree Sexual Assault in Waukesha County on 4/19/02 and Repeated Sexual Assault of the Same Child, 948.025(1) in Washington County on 12/05/2001. In all three cases the victim was a known subject to Woodall. Woodall will be on Extended Supervision (probation) until 4/11/2027 and will be monitored closely by WI-DOC Division of Community Corrections agents. Woodall will have numerous rules and restrictions to follow including wearing a live tracking GPS unit, not having contact with minors, maintaining absolute sobriety and not having a computer or internet access. The GPS technology allows DOC agents to establish "exclusion zones." If Woodall enters an exclusion zone, law enforcement will be immediately notified and will be given his location. Exclusion zones in the Allenton area will include parks and schools.

This sex offender has served the prison sentence imposed on him by the courts. He is NOT wanted by law enforcement at this time. This notification is not intended to increase fear, but rather it is our belief that an informed public is a safer public.

Sex offenders have always lived in our communities; but it was not until the Sex Offender Registration and Community Notification Law was enacted that law enforcement was able to share this information with the community.
